







HOMEOWNERSHIP SERVICES

In 2017 our Homeownership Services



Held 18 first-time homebuyer education workshops in north and south Minneapolis, providing education to 458 households.



Of workshop attendees, 74% had incomes under 80% area median income (AMI)*, 37% had incomes under 50% AMI, and 69% were households of color.



Provided free, one-on-one, pre-purchase home buyer counseling and/or financial coaching to 305 families.



Of those receiving counseling services, 70% had incomes under 80% AMI, 32% had incomes under 50% AMI, and 61% were households of color.



Of households of color participating in our pre-purchase services, 52% go on to purchase a home within three years, translating into approximately 275 new homeowners of color annually.

*Area Median Income, or AMI is the midpoint of a region's income distribution, as determined annually by the U.S. Department of Housing and Urban Development.





Provided free, one-on-one, foreclosure prevention assistance to 54 families.



Of the cases resolved in 2017, 83% avoided foreclosure.



Of foreclosure counseling clients, 80% had incomes under 80% AMI, 59% had incomes under 50% AMI, and 45% were households of color.



Since 2009, PRG has played a critical role in averting 614 foreclosures, saving over \$47.9 million in costs to homeowners, lenders and local government.



With assistance from PRG's Foreclosure Prevention Services, Wizard was able to remain in her home of over 20 years.




In 2017, 11 PRG developed homes were purchased by first time, lower income buyers, with all but one purchased by households of color, bringing the 8-year total to 92.

Of these households, the average household earned 65% of AMI, allowing these families to begin creating intergenerational wealth.

In November 2017, PRG produced a video highlighting a PRG homeowner that went viral and reached over 107,000 views. The video inspired so many people that we received phone calls from across the world and resulted in one-on-one pre-purchase advising appointments with over 50 Somali familes.

To better serve this growing community, PRG hired a Somali-speaking advisor.

In 2017, 77% of single-family construction contracts went to minority-owned businesses.

Over the past 8 years, PRG has awarded over \$12 million in single family construction contracts with 98% going to small, minority or women owned businesses.






